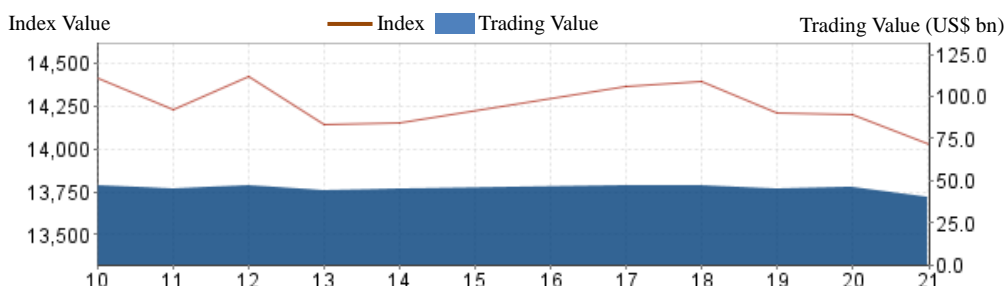

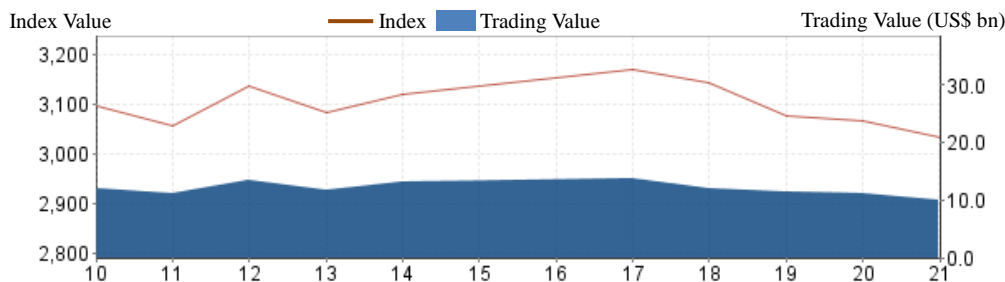

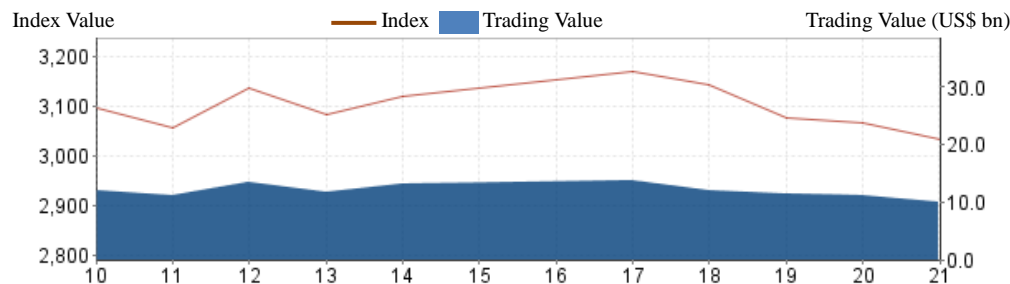
## SZSE Component Index (January 10 – January 21)
